457 abolished, new TSS
482 – temporary
employer sponsorship –
3 years to PR with
occupation on MLTSSL
only (not STSOL)

TSS visa applicants need two years of full-time work experience

Labour market testing and SAF Skilling Australians Fund

RSMS –3 years f/t work experience required

GSM – 189/190/489 – 65 points – reality – need 70/75 points to obtain invitation owing to NZ 189

Student visa stats

- A record 540,000 now studying in Australia
- Approx 25% of NOM
- Australian poised to take over #2 position for international education from UK



485 visa Stats


- > 50,000 on 485 in March 2018
- Knight Review 2011 recognised need for Australia to become competitive
- New post study stream devised
- Noted that students would find only low level jobs unrelated to their studies
- ANU Vice-Chancellor Brian Schmidt to ABC 27 Jul 18 – "very high value people" – "have the opportunity to contribute to the Australian economy"



International education gets a bad rap in the media



- Bob Birrel "gaming the system" "overseas students to blame for housing crisis and pressure on public transport"
- Group of 8 concerned about reliance on international students
- "Temporary residents with work rights out of control" – Bill Shorten leader of Labor party
- Education agent scams

Joint Standing Committee on the efficacy of migration agents

- The Joint Standing Committee on Migration shall inquire into the efficacy of current regulation of Australian migration agents
- Large focus on "unregulated" education agents
- Submission reiterates our view that this is not an industry that should be regulated as migration agents are by OMARA
- Rather give professional training and operate a trust account
